#### SUBMISSION REQUIREMENTS:

- 1) Complete the scholarship application, including the corporate endorsement form.
- 2) Submit an original 500-800 word essay, based on one of the following themes:
  - Medical: Discuss a medical impairment that you had an interest in researching, the process you used to learn about the impairment, and what you learned that you could apply to an underwritten case, enhancing the overall risk assessment process.
  - Leadership: Discuss ways that you have used your underwriting experience to educate others. Provide an overview of the educational process you developed, the outcome, what you learned from that journey, and how it has shaped you professionally.
  - Technology: Discuss ways you used your underwriting experience on a technology/analytics project that enhanced the overall risk assessment process. Provide an overview of your project participation, the process you used to learn about a new underwriting tool or technique, what you learned through your technology research, and how you encouraged new and innovated ways of thinking among your team members.
