Real Estate Act Review Task Force

Are you an experienced REALTOR® with outstanding knowledge and interest in the reshaping of Alberta real estate?

The current Real Estate Act is over 20 years old and will likely be up for review in the next election cycle. AREA has an opportunity to proactively create our suggestions to put before government, ensuring REALTORS® have a clear voice when the act is reviewed.



AREA is creating the Real Estate Act Review Task Force (REARTF). REARTF will be responsible for putting forward industry recommendations regarding changes to the real estate regulatory framework in Alberta, including:

- reviewing, discussing, and recommending the list of provisions of the Real Estate Act for amendment;
- discussing province-wide consultation strategy;
- discussing consultation findings; and
- formulating AREA's final recommendations regarding the real estate regulatory amendments to be submitted to the Government of Alberta.

Who are we looking for?

Seven (7) to nine (9) REALTORS® from across the province who have an interest in moving our industry forward via Alberta's Real Estate Act, Regulations and Rules.

What is your commitment?

Subject to a possible extension, we expect REARTF to be operational in 2018 and 2019 calendar years. Meetings will be held three times a year, with an option for additional meetings when required.

Meetings will be held in-person at AREA's office in Calgary, with videoconference participation offered to appointed task force members residing outside of Calgary.
