Member Advocacy Program



AREA recently formalized its member advocacy program, which can be called upon to support and protect members rights in legal or regulatory processes that have provincial implications.

Frank McCullough, of Coldwell Banker Mountain Central, found himself under Real Estate Council of Alberta (RECA) investigation for professional misconduct after he made comments about residential measurement standards on a private website in 2016.

Frank McCullough "I wasn't aware of the stress that being investigated by RECA would have on myself and my business," Frank says. AREA stepped up to provide legal and financial support to Frank and two other members who also made comments. All three

investigations were subsequently dropped.

AREA's member advocacy program, which is modelled on CREA's Legal Defense Program, helps members in precedent-setting instances with broad implications for all members. In Frank's case, the AREA Board decided to step in because of the infringement on a member's Charter rights to freedom of expression.

"It was comforting to know that there was someone on my side," Frank says. "This

situation wasn't about me getting in trouble for dealing in real estate, it was an investigation over something that I – and every other Canadian citizen – have the rights of: freedom of speech and association."

Jennifer McKenzie, AREA 2016 president, says, "As the provincial association, we saw these investigations and their outcomes having wide-reaching and ambiguous consequences for our broader membership. Supporting these members was an easy decision for our Board to make and their resolution provides greater protection of AREA members' freedom of expression without fear of reprisal."

Reflecting on his experience, Frank says, "I think the biggest benefit from the program was the moral support that I received from AREA. It was really encouraging to have an organization that supported me when this was happening; it really made a huge difference. I would not have received the same outcome without the assistance of AREA's member advocacy program."
