



## Wellness Spring Break Day Camp April 6th - 8th

Wellness Spring Break Day camp will be held in collaboration with Camp Fire Georgia, The Learning Tree Academy, Reins of Life, CrossFit Yona, and The Boys and Girls Club of Toccoa - Stephens County.

Wellness Spring Break Day Camp will provide youth with a safe and supportive environment where they have the opportunity to make new friends, try new activities and learn skills that they will carry with them for a lifetime. With a safe and supportive environment, children can fully engage in activities, are provided with leadership opportunities and are supported in lifting their voice. Wellness Spring Break Day Camp will include a workout of the day, Bible Stories, character building and more.

### **Arrival and Departure:**

Arrival and departure will be with the organization in which the camper is registered.

**Camp Fire Camp Toccoa:** If the camper is register with Camp Fire Camp Toccoa: drop off is between 8:15 am - 8:30 am for K-3rd and 12:15-12:30 pm for 4th-12th. Our address is 92 Camp Toccoa Drive Toccoa, GA 30577. Late drop offs will not be accepted, a refund or discount will not be given if your participant is late and not accepted. Parents/guardians are to drop participants off at the front gate. Please send your participant dressed and ready to participate. Closed toed shoes and masks **REQUIRED**. Campers will be transported to The Boys and Girls club on Monday and Tuesday, Wednesday we will remain at Camp Fire Camp Toccoa.

Pick up each day is between 12:15pm-12:30 pm for K-3rd and 4:15-4:30 pm for 4th-12th at Camp Fire Camp Toccoa. Early pickups are not allowed. Please wait at your car in the parking lot when picking up your camper. The parent/guardian picking up must show a photo ID EACH DAY to sign out their participant.

**The Learning Tree Academy:** Drop off will be between 8:30-9:00AM each day. April 6-7 the drop off location will be Boys and Girls Club of Toccoa-Stephens County 71 W Whitman St, Toccoa, GA 30577. On Wednesday, April 8th the drop off location will be Camp Toccoa 92 Camp Toccoa Drive Toccoa, GA 30577. Late drop offs will not be accepted, a refund or discount will not be given if your participant is late and not accepted. Parents/guardians are to drop participants off at the front entrance of both locations. Breakfast will be offered during drop off.

Camp Fire Georgia will provide transportation for all LTA students back to LTA at the completion of each day. If you wish to pick your child up instead of having them transported back to LTA, Pick up each day is between 12:15pm-12:30 pm. Early pickups are not allowed.

**Reins of Life / Boys and Girls Club of Toccoa-Stephens County:** These organizations will provide drop off and pick up time to campers registered with their organization prior to the event.

**Cancellations / Refunds:** Refunds will only be given if the event is cancelled by the hosting organizations. A \$3 refund fee will be applied to cover transaction fees.

**What to bring:** Please send your camper dressed and ready to participate, this is an activity based camp. **Closed toed shoes and socks are required, masks must be worn while campers are being transported and a water bottle is needed daily. Campers will be outdoors, please dress your camper for the weather.** Campers will not be admitted if they are not wearing closed toed shoes and a mask - no refund will be given.

We do not recommend sending electronics such as cell phones; if your child has a phone and/or other electronics they will be asked to keep them in their bag. Camp Fire Georgia, The Learning Tree Academy, Reins of Life, CrossFit Yona, and The Boys and Girls Club of Toccoa - Stephens County is not responsible for any lost/ stolen money or items. Additionally, we can not hold lost and found items. Please make sure your camper has all their belongings before departing.

**Health and Wellness:** Do not send your camper if they are not feeling well, have been sick, or have been around someone who has been diagnosed with COVID19. Health and wellness are at top priority of all participating organizations. All campers and staff must submit to temperature screening and health checks upon arrival. Anyone with a temperature of 100 degrees or higher may attend. Anyone knowingly exposed to someone with COVID must follow CDC guidelines for quarantine. Masks are required during transportation. Each camper must bring his/her own water bottle - paper cups provided for those who do not. Everyone will be asked to wash their hands frequently with soap and water for at least 20 seconds. Hand sanitizer will also be available in multiple locations. All food served will be individually packaged.

Our staff have been trained on how to deal with minor injury and illness. In the event that your camper experiences a more severe injury or illness, the Stephens County Hospital is a very short drive away. You will be notified if your camper is in need of medical attention. In the event of sickness, fever, injury that will require medical attention, etc. the parent will be notified to pick the participant up early from the event. Everyone is asked to wash their hands frequently with soap and water for at least 20 seconds. Hand sanitizer will also be available in multiple locations.

**Behavior Guidelines:** All participating organizations strive to provide a positive atmosphere where children develop good social skills and grow as individuals within a group setting. Inappropriate behavior from a few campers can affect the experience for the entire group. Campers will be informed of our expectations and the consequences of inappropriate behavior. The staff will do their best to manage problems as they arise. Depending on the severity of the offense, parents may be contacted immediately. Our program cannot accommodate campers who display chronic or severely disruptive behavior. Such behavior may be grounds for dismissal from the program. Chronically disruptive behavior is defined as verbal or physical activity, which may include, but is not limited to: Behavior that requires constant attention from the staff. Behavior that inflicts physical or emotional harm on children or staff (i.e. verbally or physically threatening behavior, fighting, etc.). Behavior that is destructive in nature. Behavior that continually ignores or disobeys. We have a zero-tolerance policy for certain items/situations. Participants, parents and staff will be dismissed from our programs for the following offenses: Bringing drugs, alcohol, or weapons of any kind to our programs. Acting in a physically or sexually abusive or harassing manner towards any other person, parent, staff or participant.

**Social Network and Blog Policies** Campers along with parents/ guardians must be respectful in all communications and blogs related to or referencing all participating organizations, its employees, and other participants. Campers must not use blogs or personal web sites to disparage any of the participating organizations and/or other participants or employees of participants organizations. Campers must not use blogs or personal web sites to harass, bully, or intimidate other participants or employees of any of the participating organizations. Behaviors that constitute harassment and bullying include, but are not limited to, comments that are derogatory with respect to race, religion, gender, sexual orientation, color, or disability; sexually suggestive, humiliating, or demeaning comments; and threats to stalk, haze or physically injure another person.
