SPA 8th grade students will be attending an overnight retreat to Tonto Rim Christian Camp (TRCC) at 353 North Baptist Camp Road, Payson, AZ 85541, on **Friday, September 6, 2019**. Students will board buses for a **7:00AM** departure to Tonto Natural Bridge State Park. Students will be accommodated overnight at TRCC and return to SPA at approximately **1:00PM** for pick up on **Saturday, September 7, 2019**.

Dress Code: Field Day dress code will be strictly enforced (see pg. 61 of the Family Handbook).

Food & Drink: Students should be sure to eat a nourishing and filling breakfast before the day begins. All additional snacks and meals will be provided.

Cost: **\$150** (includes food, accommodations, transportation and event activities)

Decorum: As this is a school trip, all school rules will remain in effect during the trip. This includes our prohibition on student electronics (e.g. cell phones). Students with urgent issues will have access to a phone.

Behavioral Contract



1. In general, Students will abide by the spirit of the SPA Family Handbook.
2. Students will follow directions given by chaperones in all circumstances.
3. Students are not allowed to go anywhere without at least one other person.
4. Students must ask permission from their chaperone before leaving their group for any reason.
5. Use of tobacco, alcohol, or illegal substances is strictly forbidden.
6. Personal listening devices (I-pods, etc.) must be left in the cabins during the day.
7. Cell phones may be checked out from chaperones for brief periods of time in the evenings for the sole purpose of communicating with parents.
8. Students must remain in their cabins throughout the night and remain there until dismissed the next morning.
9. Students will not socialize at any time in the rooms assigned to members of the opposite sex.
10. All prescription and over the counter (OTC) medications that a student will need on the retreat will be turned into retreat leadership during registration at school on the first day of the retreat. Students are not authorized to have medications in their custody during the retreat. Medications will be dispensed to students by chaperones according to the plan laid out on the student's "Parental Consent Form to Dispense Medication."
11. The "Athletic Practice and Outdoor Field Day" Dress code shall be in effect for the retreat. The specifics of this dress code can be found in the Family Handbook which can be accessed at the SPA website.
